2. Change for Original Permit Request: We propose using Class A [Type 1] cement. The total depth of this well, according to Drilling Logs is no more than 625 Feet.

3. The above stated request for an extension and changes/ modifications of cement were discussed and verbally authorized by Jim Amos pending receipt of Sundry Notice.
