Perforated Delaware 6784' to 6837' (Total 53 holes). Acidized with 2000 gal.. 7 1/2% Nefe HCL Acid and 80 ball sealers. Fracture stimulated via 5-1/2" casing at 51 BPM With 70,040 Gal.. 10 # Brine and 9000 # 14/30 Liteprop125 + 2000 # 20/40 White sand + 15,000 # 16/30 Siberprop. Installed rod pump and test produced well.
