With consideration given to unsuccessful fishing operations, BOPCO, L.P. respectfully wishes to abandon the wellbore below 11,500' for the above captioned well. At 11,954' the drill string became stuck and fishing operations have effectively removed the majority of the bottom hole assembly to a depth of 11,825'. The remainder of the fish was not recovered. The wellbore will be abandoned by placing 250 sacks of Class H cement, mixed at 17.5 ppg (0.95 cu.ft/sx yield) from 11,325' - 11,825'. The well will then be sidetracked and re-drilled from 11,425' to a total depth of approximately 13,030'.
