In an effort to improve primary cementing on the production casing, we now propose to perform 2-stage cementing as follows:

Cementing 5-1/2" - DV Tool @ ~5260'

Stage 1: 209 sacks Lead 35:65 Poz:Class C + 5% D44 (bwow) + 6% D20 + 0.125 pps D130 + 0.1% D13 (yield=2.04) mixed 12.6 ppg and 200 sacks Tail Class C + 0.125 pps D130 + 0.2% D13 (yield=1.32) mixed 14.8 ppg. Includes 25% excess.

Stage 2: 91 sacks Lead 35:65 Poz:Class C + 5% D44 (bwow) + 0.2% D167 + 0.1% D13 + 0.125 pps D130 (yield=1.93) mixed 12.6 ppg and 200 sacks Tail Class C + 0.125 pps D130 + 0.2% D13 (yield=1.40) mixed 13 ppg.

Top of cement @ 3120'. Includes 25% excess.

Actual placement of DV tool and cement volumes for 5-1/2" casing to be determined by openhole caliper log.

If DV tool set deeper than 3260' - excess cement will be less than 25% on 2nd stage
