APPLICATION OF DAKOTA RESOURCES, INC.

ADMINISTRATIVE ORDER OF THE OIL CONSERVATION DIVISION

Under the provisions of Rule 701(B), Dakota Resources, Inc. made application to the New Mexico Oil Conservation Division on January 23, 1992, for permission to complete for salt water Big Eddy Federal #100 located in Unit L of Section 8, Township 21 South, Range 28 East, NMPM, Eddy County, New Mexico.

THE DIVISION DIRECTOR FINDS THAT:

- (1) The application has been duly filed under the provisions of Rule 701(B) of the Division Rules and Regulations.
- (2) Satisfactory information has been provided that all offset operators and surface owners have been duly notified; and
- (3) The applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 will be met.
- (4) No objections have been received within the waiting period prescribed by said rule.

IT IS THEREFORE ORDERED THAT:

(1) The applicant herein, Dakota Resources, Inc. is hereby authorized to complete its Big Eddy Federal #100 located in Unit L of Section 8, Township 21 South, Range 28 East, NMPM, Eddy County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the Delaware formation at approximately 2886 feet to approximately 5657 feet through 2 7/8 inch plastic lined tubing set in a packer located at approximately 2850 feet.

IT IS FURTHER ORDERED THAT:

The operator shall take all steps necessary to ensure that the injected water enters only the proposed injection interval and is not permitted to escape to other formations or onto the surface.

Prior to commencing injection operations into the well, the casing shall be pressure tested from the surface to the packer setting depth to assure the integrity of said casing.

The casing-tubing annulus shall be loaded with an inert fluid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of leakage in the casing, tubing or packer.

The injection well or system shall be equipped with a pressure limiting device which will limit the wellhead pressure on the injection well to no more than 577 psi.

The Director of the Division may authorize an increase in injection pressure upon a proper showing by the operator of said well that such higher pressure will not result in migration of the injected fluid from the Delaware formation. Such proper showing shall consist of a valid step-rate test run in accordance with and acceptable to this office.

The operator shall notify the supervisor of the Artesia district office of the Division of the date and time of the installation of disposal equipment and of the mechanical integrity test, so that the same may be inspected and witnessed.

The operator shall immediately notify the supervisor of the Artesia district office of the Division of the failure of the tubing, casing or packer in said well and shall take such steps as may be timely and necessary to correct such failure or leakage.

PROVIDED FURTHER THAT, jurisdiction of this cause is hereby retained by the Division for such further order or orders as may be deemed necessary or convenient for the prevention of waste and/or protection of correlative rights; upon failure of the operator to conduct operations in a manner which will ensure the protection of fresh water or in a manner inconsistent with the requirements set forth in this order, the Division may, after notice and hearing, terminate the injection authority granted herein.

The operator shall submit monthly reports of the disposal operations in accordance with Rule 706 and 1120 of the Division Rules and Regulations.

- (2) That satisfactory information has been provided that all offset operators and surface owners have been duly notified; and
- (3) That the applicant has presented satisfactory evidence that all requirements prescribed in Rule 701 will be met.
- (4) That no objections have been received within the waiting period prescribed by said rule.

IT IS THEREFORE ORDERED:

That the applicant herein, Fluid Waste Inc., is hereby authorized to complete its Dorstate SWD Well No. 1, located in Unit H of Section 27, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico, in such a manner as to permit the injection of salt water for disposal purposes into the Bone Springs formation at approximately 6376 feet to approximately 6825 feet through 2 7/8 inch plastic lined tubing set in a packer located at approximately 6310 feet.

IT IS FURTHER ORDERED:

That the operator shall take all steps necessary to ensure that the injected water enters only the proposed injection interval and is not permitted to escape to other fermations or onto the surface.

That the casing-tubing annulus shall be loaded with an inert (tuid and equipped with a pressure gauge at the surface or left open to the atmosphere to facilitate detection of left me in the caring, tubing, or packer.

That the injection well or system shall be equipped with a processor limiting device which will limit the wellhead pressure on the injection well to no more than 1275 psi.

That the Director of the Division may authorize an increace in injection pressure upon a proper showing by the operator of raid well that such higher pressure will not result in migration of the injected fluid from the Bone Springs termation. That such proper showing shall consist of a valid step-rate test run in accordance with and acceptable to this office.

That the operator shall notify the supervisor of the Artesia district office of the Division of the date and time of the installation of disposal equipment so that the same may be inspected.

That the operator shall immediately notify the supervisor of the Division's Artesia district office of the failure of the bubing, casing, or pocker, in said well or the leakage of vater from or around said well and shall take such steps as may be timely and measury to correct such failure or leakage.

PROVIDED FUPTHER, That jurisdiction of this cause is hereby retained by the Division for such further order or orders as may seem recommany or convenient for the prevention of waste and/or protection of correlative rights; upon failure of applicant to comply with any requirement of this order after notice and hearing, the Division may terminate the authority hereby granfold in the interest of conservation. That applicant shall a built menthly reports of the disposal operations in accordance with hule 706 and 1120 of the Division Rules and Demonstrons.

NOTE: This order has been amended to change the injection interval from the beloware Formation to the Bone Springs Formation.
