Chesapeake Operating, Inc. is to use a closed loop system in the plug and abandonment of this well.

(1) 250 bbl frac tank

Operations & Maintenance:

During plugging operations, the rig's crew will inspect and monitor closely all fluids contained within the steel tank and visually monitor any spill which may occur.

Within 48 hours should a spill, release or leak occur, the NMOCD District II office in Artesia (575-748-1283) will be notified. Please note that notifications may be made earlier to the district office should a greater release occur.

This is in keeping with the reporting requirements of NMOCD's rule 116.

Closure:

After plug and abandonment operations, fluids will be hauled and disposed by transport truck to the Controlled Recovery, Inc.'s (CRI) location.
