I have recieved a permit to drill application from the City of Carlsbad for the above referenced Chi Energy well. They are proposing to drill a 5400' Delaware Fm. test. When you approve this permit could you please forward me the assigned API number so I can browse the OCD e-permit file for this well.

I have briefly looked at the application and it appears that it does not confirm the minimum required distance from a commercial or residential building. I will be in Carlsbad on Thursday and will get with Mr. Aguilar and confirm distance to nearest buildings. If I remember correctly, the well is located in a large field and should be good to go except if located across (east) from DOE offices and north of residential area located south of Chapman Road.

Chi proposes to set 350' of 8 5/8" surface pipe. Will that be sufficient depth to cover total depth of fresh water. The only reference I have for the area is the Mewbourne Oil Co. Pecos River 20 API # 015-34230 well which set surface pipe to 400'.

Finally, a reserve pit diagram was included that proposed an open earthen pit. Will that meet Rule 50 requirements? Groundwater will be approximately 30' below ground surface in this area. I am fairly sure it will not meet the new regs presently being discussed at OCD but I do not know the status of the new regs.

I will wait on your (OCD) final approval of the C-101 before I complete my review.
