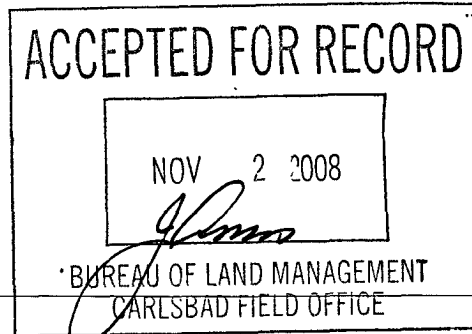

Perforated 11,759'-11,763', 11,720'-11,730', 11,708'-11,714', 11,695'-11,704', 11,604'-11,614', and 11,566'-11,572' w/ 1-11/16" strip gun, 1 JSPF, 0° phasing, .25" EH, 51 holes in 6 runs. POW and RDWL. Turned well through compressor at 160 mcfpd, FTP-180 psi.
