Marbob Energy Corporation respectfully requests administrative approval for an unorthodox location of the Burch Keely Unit #992 well as referenced above. Attached is an OCD Form C-102 showing the proposed oil well spacing unit along with a map showing the adjoining spacing units. This well is unorthodox to the east boundary of the SW/4NE/4. The affected spacing unit is included in the Burch Keely Federal Unit which covers all of Section 18. Notice has been provided to the operator and working interest owners of that unit.

This location will also increase our secondary/tertiary flood pattern options and give us more flexibility to modify or change flood patterns in the future to maximize oil recovery from this unit. The surface problem encountered was cultural and this was the closest acceptable location.
