BEPCO, LP respectfully request permission to temporarily zone abandon the Pierce Crossing (Bone Spring) perforations at 8303-9239' by setting a 10 K CIBP @ 7410'. Delaware perfs will be added from ~6990-7000' and Avalon perfs from ~7290-7300' and stimulated and put on production from the new perfs only.

After a period of production to establish well test data, a downhole commingle permit will be sought to produce the wellbore from both the 1st & 2nd Bone Spring and the Delaware/BS/Avalon) formations.
