PU 1" pipe & tag @ 90'. Cmt 1st plug w/50 sks Class C w/4% CaCl₂. Circ 15 sks cement to pit. WOC 18 hrs. At 1:00 am 11/23/08 tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 7 7/8" bit.

11/26/08 TD'ed 7 7/8" hole @ 3252'. Ran 3252' 4 1/2" 11.6# P110/J55 LT&C csg. Cemented w/300 sks BJ Lite Class C (35:65:6) with additives. Mixed @ 12.5 /g w/1.94 yd. Tail with 400 sks Class H with additives. Mixed @ 15.1 /g w/1.29 yd. Plug down @ 1:30 pm 11/27/08. Circ 58 sks cement to pit. At 1:30 pm on 11/27/08, tested csg to 1450# for 30 mins, held OK. Set wellhead slips w/45k.
