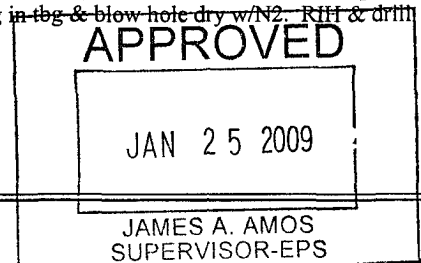

3. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Mewbourne Oil Company request approval to DHC Happy Valley Morrow, Happy Valley Atoka, & Happy Valley Canyon. Morrow is currently producing from 11278' to 11512' with rates of 230 MCF, 0 BO, 3 BW. The Atoka is to be perforated from 10490' to 10500'. Morrow perfs will be temporarily isolated with a composite BP. Canyon will be perforated from 9832' to 9860' with a composite BP temporarily isolating the Atoka. Commingling of these 3 pools will not reduce the value of remaining reserves. The ownership of all pools is identical. All 3 zones included in NM-56520.

Procedure to downhole commingle: Set plug in tbg and blow well dry with N2. Release pkr & POOH. Set BP @ 11250'. Perforate Atoka @ 10490' to 10500'. Flow test & stimulate as needed. Set plug in tbg & blow well dry with N2. Release pkr & POOH. Set BP @ 10400'. Perforate Canyon @ 9832' to 9860'. Flow test & stimulate as needed. Once production falls below minimum required velocity set plug in tbg & blow well dry w/N2. RHT & drill out BP @ 10400' and 11250' w/air foam unit. PWOL.

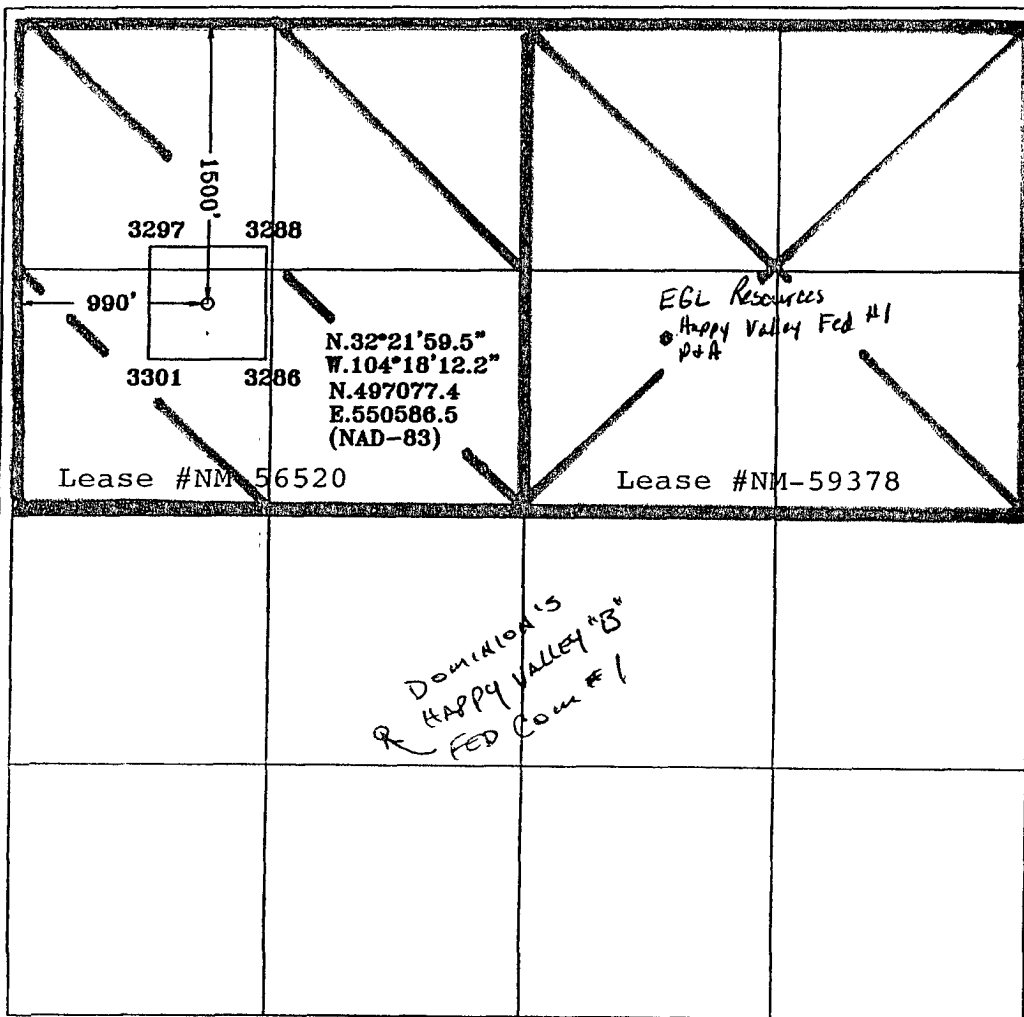
