Circ cmt up conductor to pit. Drilled 12-1/4" hole to 420'. On 1/9/09, set 8-5/8" 24# J-55 csg @ 420'. Cmted w/375 sx (499 cf) cl "C" cmt w/2% Cacl2 & 1/4# C/F. Circ 140 sx cmt to pit.

Drilled 7-7/8" hole to TD3603' on 1/17/09 & set 5-1/2" 17# J-55 production csg @ 3603'. Cmted w/400 sx (716 cf) 35/65 POZ "C" cmt w/5% salt, 0.2% FL-200. & 1/4# super flake & tailed w/400 sx (532 cf) cl "C" cmt w/0.2% CD-20, 0.3% super FL, & 1/4# super flake. Circ 137 sx cmt to pit. Released drilling rig on 1/18/09. Plan to pressure test 5-1/2" csg during completion operations.
