Edge Petroleum will be changing the gas sales pipeline for said well. The current pipeline is a 4" high pressure buried line. Construction for the new line will begin Jan. 22, 2009 and last approx. 10 days. The new line will be 1700' of 3" SDR-7 heavy wall poly line which will lay along side the existing ROW. This will insure that no further surface damage will occur. The pipeline will run from existing well location to an existing DCP line for tie in.
