BOPCO, LP respectfully request permission to temporarily zone abandon the Morrow formation @ 12,055' to 12,519' by setting a CIBP in the Model 'D' packer tail pipe, 2-3/8" tubing sub, below the current Baker Hornet packer set @ 11,962'. The Atoka formation will then be perforated from 11,418' to 11,529' OA. The formation will be stimulated w/ 5000 gals. 7.5% HCL.

After a period of production to establish well test data, a downhole commingle permit will be sought to produce the wellbore from both the Morrow and the Atoka formations.


This is a new wellbore and the initial completion has not been previously filed due to no production being achieved.
