Drilled 7-7/8" hole to TD3606' on 2/25/09 & set 5-1/2" 17# J-55 production csg @ 3596'. Cmted lead w/400 sx (760 cf) 35/65 POZ "C" cmt w/5% salt, 0.3% FL-200, & 1/8# super flake & tailed w/400 sx (548 cf) cl "C" cmt w/0.3% FL-200 & 1/8# super flake. Circ 197 sx cmt to pit. Released drilling rig on 2/26/09. Plan to pressure test 5-1/2" csg during completion operations.
