Drill cuttings are currently contained on drying pad and fenced. There was also a cuttings burial trench started under rule 50 but trench was not utilized. Drill cuttings and drying pad liner will be hauled to Lea Land, Land Fill (Permit NM1-35-0). Composite samples of the pad area will be taken and tested for all regulated toxic materials. Trench will be back filled with topsoil and entire drying pad area will be reclaimed and reseeded. Final closure will be submitted when work is finalized.
