ACIDIZE W/ 3000 GAL NEFE 15% HCL ACID. SWAB/FLOW TEST. PERF THE CISCO W/ 1 SPF @ 8932' - 9025' (11 SHOTS). STRADDLE @ 8932' - 9025'. ACIDIZE W/ 3000 GAL NEFE 15% HCL ACID. SWAB/FLOW TEST. PERF THE BASAL ABO W/ 1 SPF @ 8084' - 8246' (10 SHOTS). ACIDIZE W/ 5000 GAL NEFE 20% HCL INHIBITED. SWAB TEST.
