BOPCO, LP respectfully requests permission to downhole commingle the production between the Nash Draw (Delaware/BS/Avalon) and the Pierce Crossing (Bone Spring) East in this wellbore. On a sundry notice approved by the BLM on 11/28/2008, BOPCO, L.P. was granted permission to temporarily zone abandon the Pierce Crossing (Bone Spring) East perforations at 7616'-9160' and then to perforate the Delaware/BS/Avalon from 6571'-6935'. The wellbore has been producing from the Delaware interval since March 2009.

BOPCO, L. P. requests permission to drill out 2 CIBPs @ 7010' & 7050' and produce both formations simultaneously. The interest ownership is the same in both of these unitized zones.

The NMOCD has also been petitioned for approval to downhole commingle these two zones.
