BP America proposes to withdraw its NOI dated 10/2/08 to P&A this well and instead return the well to production after perfring and treating Upper Abo pay intervals The following remedial work is proposed:

- 1 MIRU PU, install BOP and test 4½" casing from 0' - CIBP @ 6080' to 500 psi
- 2 Make bit & scraper trip to CIBP, circulate hole clean and spot acetic acid across zones to be perfring
3. Perforate Upper Abo at the following intervals w/ 2 SPF: 5896' - 5902' 5949' - 5955' 5979' - 5982' 6000' - 6006' 6026' - 6030' 6047' - 6050' & 6056' - 6060'
- 4 Acidize Abo perfs 5896' - 6060' with total of 4000 gals 15% HCL-NE acid using straddle packer assembly Swab test perfs after acidizing
- 5 Run rod pumping equipment and place well on pump.
