Yates Petroleum Corporation respectfully requests permission to extend the Temporary Abandon status of this well in order to test the Wolfcamp dolomite, when economic conditions are better. A Wolfcamp well in this section has produced 19,000 bbls of oil, but unfortunately it also produced 203,000 bbls of water. This well is also a potential deepening candidate. We do not want to permanently plug this well bore yet.
