Acidized Morrow perfs 9731'-9881' with 2000 gals 7-1/2% foamed acid as follows: Pumped 2000 gals of 50 Quality 7-1/2% Hcl acid containing 1 gpt I-13 corrosion inhibitor, 2 gpt NE-14 non-emulsifier, 2 gpt NE- 15 non-emulsifier, 3 gpt FE-19 iron control, 2 gpt F-13 foamer, 2 gpt FR-10 friction reducer and 2 gpt CS- 13 clay stabilizer while dropping 70- 7/8" 1.3 sg ball sealers evenly spaced for diversion. Flushed to top perforation with 100% CO2.

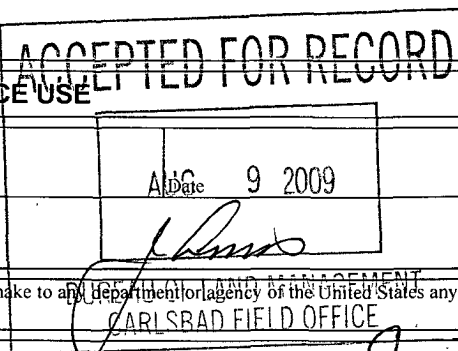
