BOPCO, LP respectfully wishes to report the interim reclamation of the subject wellsite. The surface was reclaimed in keeping with the "Multi-Point Surface Use Plan" in the original APD for the Poker Lake Unit #276. Hauled approximately 648 yards of caliche from location and used to repair various lease roads at Nash Draw. Reclaimed land has been seeded with BLM seed #3 & #4. The site has been down-sized with the remaining wellpad designed to accomodate production operations.

Additionally, bird netting has been installed on the chemical bulk tank containment.

Site is ready for interim reclamation inspection.
