

13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 1. Remove 1' or 2' contaminated soil and protruding plastic and disposed of at an approved facility
2. Replace with 2' of clean topsoil. Level, spread, and contour to surrounding area
3. Remove 1 mile of access road. Level and contour to surroundings
4. Build earthen berm at access road entrance to prevent vehicular traffic.
5. Rip entire pit and access road with # 3 and # 4 BLM seed mixture as requested
