August 27, 2009 - Spud Well at 11 am. Drill to 400' run 8 5/8", 24# J-55 casing and circulate cement to surface with 175 sax. BLM representative notified and came to location but left before cement job was completed.

August 28, 2009- WOC. Delivered surface cement report to BLM from Superior Well Services.

August 29, 2009 - Resume drilling out cement

August 30, 2009 - completed drilling to TD of 1200'. Prepare to Log Well

August 31, 2009 - run 4 1/2", 10.6#, J-55 casing to 1200'.

September 1, 2009 - cement 4 1/2" casing with 200 sax circulated to surface.

September 9, 2009 - Perforate 1047' - 1064' 6 spf. Prepare to swab well. No entry. Acidize with 2000 gallons of 15% HCL. No show. RIH with CIBP and set @ 1030'.

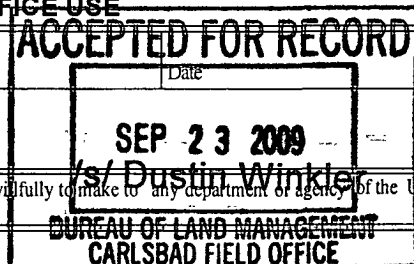
