9/11/09: MIRU Knight Oil Tool. Tag CIBP @ 6979 and drill out. TAC @ 5,735' 7,258'. EOT @ 7293'.

9/12/09: Run production equipment and connect well to flowline.

9/13 - 10/8/09: Return well to production. Best production 9/15/09: (P) 15 BO, 78 BW, 29 MCF. TP - 300 p si, LP - 56 psi, CP - 70 psi, on wide open choke.

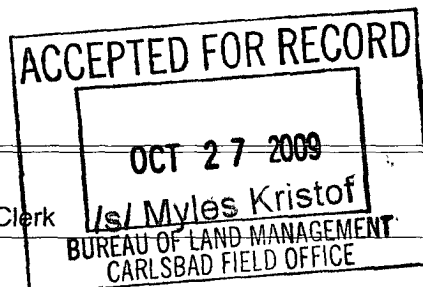
