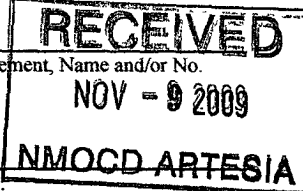

Spudded well on 10/13/09. Drilled 12-1/4" hole to 395'. On 10/13/09, set 8-5/8" 24# J-55 csg @ 385'. Cmted lead w/175 sx (236 cf) cl "C" cmt w/2% Cacl2 & 1/8# PE flake. Tailed w/200 sx (270) cl "C" cmt w/2% Cacl2. Circ 166 sx cmt to pit. On 10/14/09, PT 8-5/8" csg to 500 psi for 30 min - OK. J Barkley w/BLM observed cmt job. L Brumley w/BLM observed testing.

Drilled 7-7/8" hole to TD3630' on 10/22/09. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 3614'. Cmted lead w/450 sx (851 cf) 35/65 POZ "C" cmt w/3% salt, 3# gilsonite, & 1/8# PE flake & tailed w/400 sx (532 cf) cl "C" cmt w/0.4% LAP-1, 0.5% CFR-3, 0.25# D-air, & 1/8# PE flake. Circ 158 sx cmt to pit. Released drilling rig on 10/24/09. Plan to pressure test 5-1/2" csg during completion operations.
