Mixed @ 14.8 /g w/1.34 yd. Plug down @ 2:30 pm 11/23/09. Did not circ cmt. Slow rate lift pressure @ 210# @ 3 BPM. WOC. Ran temp survey indication TOC @ 290'. RIH with 1" pipe. Tag at 348'. Ran 1" pipe in 4 stages with 708 sks Thixad Class H with additives. Mixed @ 14.6 #/g w/ 1.52 yd. Circ 10 sks to pit. WOC 18 hrs. At 4:00 pm 11/24/09 tested casing to 1500# for 30 minutes, held OK. Drilled out with 7 7/8" bit.
