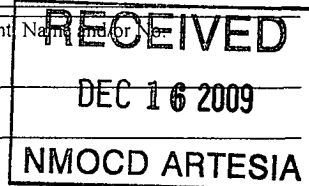

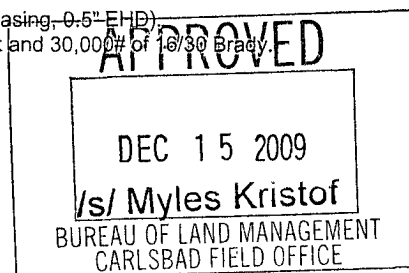
Proposed well completion procedure:

RU Wireline & run GR/CCL/CBL logs. RIH w/3-1/8" select-fire csg guns and perforate 2667'-2842' (4 SPF, 90 deg phasing, 0.5" EHD). Acidize using 5,000 gal 15% NEFE, scale inhibitor and ball sealers. Frac w/ approx. 18,000 gal of 25# cross-linked gel and 30,000# of 16/30 Brady. Leave well SI overnight. RU flowback equipment, install choke, open to flowback tank.

RIH with 2-7/8" 6.5# 8rd EUE J-55 tubing, 2-7/8" SN.

RIH wgas anchor, pump and rods. Load and test to ensure good pump action.
