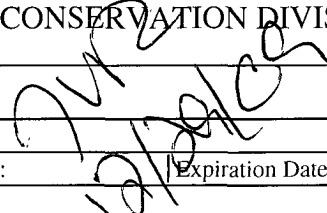

Drill 17 1/2 inch hole with fresh water, set 13 3/8 48# H-40 casing and cement to surface. Drill 12 1/4" hole to 2300' with brine, run 9 5/8" 36# J-55 and cement to surface. Drill 7 7/8" hole to 9400', with cut brine then run electric logs, plug back and drill to new bhl (tvd 6500) run 5 1/2 17# N80 casing and cement to 1500'

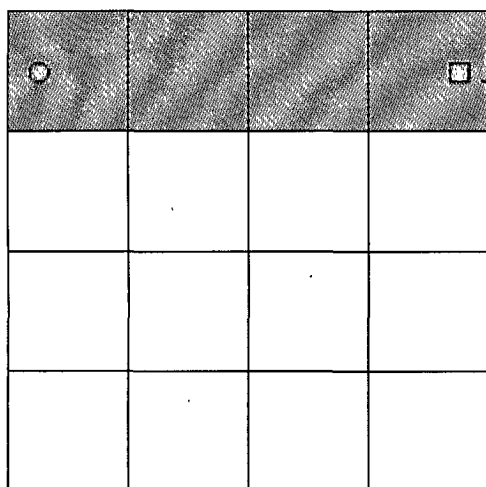
