Objective: Convert the well from a Paddock and Blinebry producer to a Paddock and Blinebry water injection well. (Pumping unit will be moved prior to conversion.)

Procedure:

1. MIRU, Tag PBTD, POH w rods, pump, and tbg. (PBTD @ 5396')
60 – 7/8" T66 rods, 136 – 3/4" T66 rods, 12 – 7/8" T66 rods.
169 jts 2 7/8" tbg.
2. Run a 4 3/4" bit and 5 1/2" csg scraper and clean out to PBTD.
3. TIH w PKR and 2 7/8" tbg and set PKR @ 5045'.
4. Acidize Blineberry perms 5145'-5288' with 1,000 g 15%. Flowback and swab if necessary.
5. TIH w PKR and RBP and set RBP @ 5100' and PKR at 4633'.
6. Acidize Blineberry perms 4733'-5042' with 1,000 g 15%. Flowback and swab if necessary.
7. TIH w PKR and RBP and set RBP @ 4625' and PKR @ 4236'.
8. Acidize the Blineberry perms 4336'-4573' with 1,000 g 15%. Flowback and swab if necessary.
9. TIH w PKR and RBP and set RBP @ 4250' and PKR @ 3773'.
10. Acidize the Paddock perms 3873'-4214' with 1,000 g 15%. Flowback and swab if necessary.
11. TIH with 2 7/8" injection tbg and injection PKR and set PKR at 3773'. Test csg and tbg to 2000 psi. Circulate 57 bbls of PKR fluid between 2 7/8" tbg and 5 1/2" csg.
12. Begin injection as permitted on the C108.
