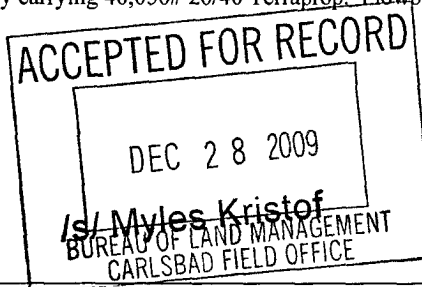

12/12/09 Frac w/1000 gals 7 1/2% NeFe HCl acid. Followed by 40,700 gal 40# 70Q Binary carrying 40,050# 20/40 Terraprop. Flowback for cleanup.

12/14/09 Put well on production.
