Yates Petroleum Corporation plans to plug and abandon this well as follows:

1. MIRU all safety equipment as needed.
2. Set a 4-1/2" CIBP at 2661' and cap with 25 sx Class "C" cement. This will place a plug from 2321'-2661' across the Glorieta top over the perforations.
3. Circulate hole with salt gel mud. Spot 25 sx cement plug across the intermediate casing shoe from 1000'-1340'. WOC and tag plug, reset if necessary.
4. Spot 25 sx cement plug across the surface casing shoe from 0-300'. WOC and tag plug, reset if necessary.
5. Cut off wellhead and install dry hole marker and clean location as per regulated.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits

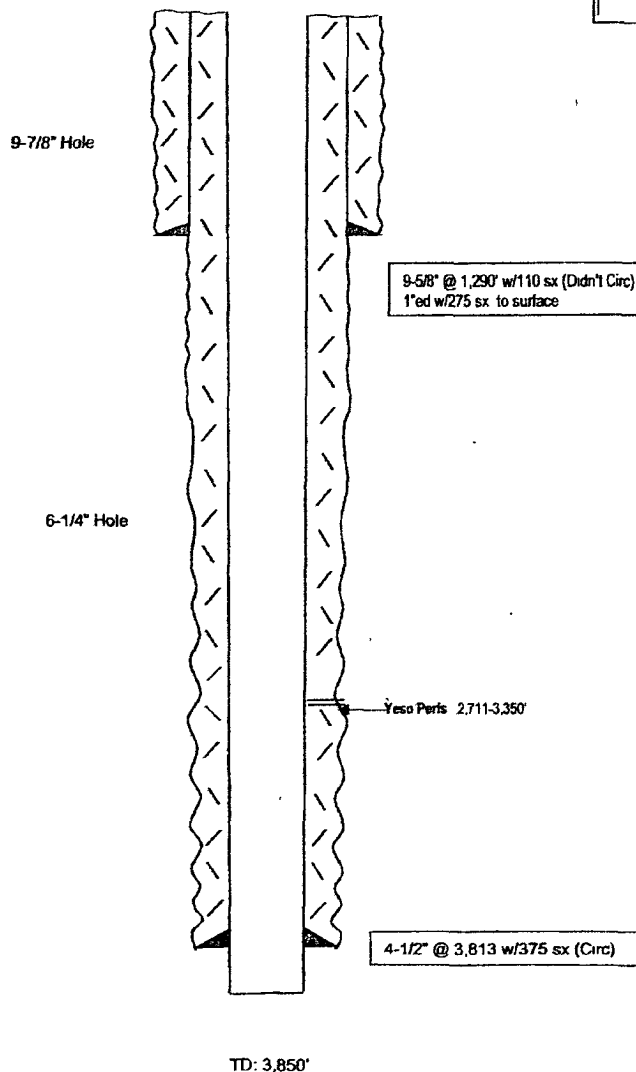
