Mack Energy Corporation proposes to plug and abandon well as follows:

1. Notify OCD 24 hours prior to starting plugging operations.
2. Set 100' cement plug from 1721-1621'. WOC and tag.
3. Circulate hole with mud gel.
4. Perforate @ 563' squeeze ~~100'~~ ^{203'} cement 50' above and below 8 5/8 casing. WOC and tag. Place cement out of 159 360'-563'
5. Perforate @ 250' squeeze 100' cement back to 150'. - Both strings
6. Perforate @ 60' circulate cement to surface. - Both strings - WOC 24 HRS - TAG
7. Install dry hole marker.
