Spudded well on 3/22/10. Drilled 12-1/4" hole to 490'. On 3/22/10, set 8-5/8" 24# J-55 csg @ 474'. Cmted lead w/200 sx (270 cf) cl "C" cmt w/2% Cacl2 & 1/4# PE flake. Tailed w/200 sx (270) cl "C" cmt w/2% Cacl2. Circ 112 sx cmt to pit. On 3/23/10, PT 8-5/8" csg to 500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3233' on 3/29/10. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 3217'. Cmted lead w/350 sx (701 cf) 35/65 POZ "C" cmt w/3# salt, 3# gilsonite, & 1/8# PE flake & tailed w/400 sx (532 cf) cl "C" cmt w/0.4% LAP-1, 0.5% CFR-3, 0.25# D-air, & 1/8# PE flake. Circ 178 sx cmt to pit. Released drilling rig on 3/30/10. Plan to pressure test 5-1/2" csg during completion operations.
