Cement 2nd plug @ 11350'-11140' w/100 sx. Class "H" w/0.15% R3 (yield @ 1.18 cf/sk. @ 15.6 PPG). TOOH w/10 stands & WOC 4 hrs. TIH & tagged @ 11170'.

Cement 3rd plug @ 9375'-9185' w/100 sx. Class "H" w/0.1% R3 (yield @ 1.18 cf/sk. @ 15.6 PPG). TOOH w/10 stands & WOC 4 hrs. TIH & tagged @ 9167'.

Cement 4th plug @ 7850'-7550' w/200 sx. Class "H" w/1% CD31, 2% Salt & 0.1% R3 (yield @ 0.95 cuft/sk @ 17.5 PPG). Drill cmt from 7550' to 7740'.

Cement 5th plug @ 7740'-7440' w/200 sx Class "H" w/1% CD31 & 3% Salt (yield @ 0.9 cuft/sk. @ 18 PPG). Drill out cmt from 7303' to KOP @ 7604'. Start drlg Bone Springs horizontal section.
