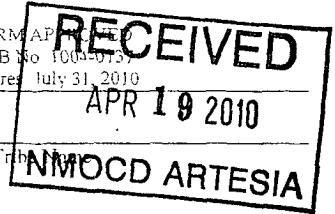

XTO will need to lay an additional 700' of 6" line to get the production from the Nash #39H Well Surface Location 2415' FSL & 1645' FWL, Nash #40H Surface Location 2374' FSL & 616' FWL and the Nash #41H (Surface Location 2456' FSL & 1674' FWL) all in Section 12 T23S, R29E Eddy County, NM to market (plat attached). Under the BLM Standard Set of Stipulations, as this line is larger than 4" in diameter, XTO will bury said line at the prescribed depth of 36". All of these wells are on the leased premises with said lease being committed to the unit and all production from these wells is unit production.
