6/18/10 – Resumed drilling at 7:30 AM. TD 17-1/2" hole to 470'. Set 13-3/8" 48# H-40 ST&C casing at 470'. Cemented with 165 sx Class "C" + 0.125#/sx D130 + 4% D20 + 2% S1 + 0.2% D46 (yld 1.96, wt 12.9). Tailed in with 200 sx Class "C" + 0.5% S1 (yld 1.34, wt 14.8). Circulated 120 sx to pit. Tested casing to 600 psi for 30 min. WOC 22 hrs 45 min. Reduced hole to 12-1/4" and resumed drilling.

6/21/10 – TD 12-1/4" hole to 2232'. Set 9-5/8" 36# J-55 LT&C casing at 2232'. Cemented with 560 sx 35:65:6 Poz "C" + 0.125#/sx D130 + 2#/sx D142 + 6% D20 + 5% D44 + 0.2% D46 (yld 2.08, wt 12.6). Tailed in with 200 sx Class "C" (yld 1.33, wt 14.8). Circulated 140 sx to pit. Tested casing to 1200 psi for 30 min. WOC 20 hrs 36 min. Reduced hole to 8-3/4" and resumed drilling.
