Spudded 12 1/4" hole 2:15 pm 8-14-2010. Drilled to 300' KB and ran 7 jts 8 5/8" 24 #/ft surface csg and cemented w/200 sx cement. Cement circulated to surface (circulate 21 sx to pit). WOC 18 hrs. Pressure test BOP and 8 5/8" surface csg to 1500 psig for 30 minutes. Held OK.

Drilled 7 7/8" hole to 2700' KB. Ran 65 jts 5 1/2" 15.50 #/ft csg, set at 2692' KB. Cemented w/700 sx cement. Plug down 3:15 am 8-21-2010. Circulate cement to surface (circulate 109 sx to pit).
