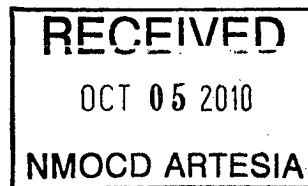

Inspect rods and tubing, replace as necessary.
Install new pump.
Run tubing, pump and rods.
Repair surface pumping equipment as necessary for proper operation.
Resume production.

As per 43CFR3162.4-1(c) Notify this office within 5 days of well being placed on production and submit daily well production volumes on sundry notice. Provide verification that well is capable of producing in paying quantities.
