Tail with 400 sks Class "H" w/additives. Mixed @ 15.6 #/g w/ 1.19 yd. Plug down @ 7:30 am 09/29/10. Did not circ cmt. Slow rate lift pressure @ 1760# @ 3 BPM. At 145 am on 10/01/10 tested BOPE and casing to 1500# for 30 minutes, held OK. Drilled out with 6 1/8" bit.

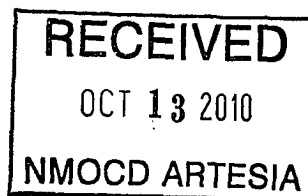
