Rule 19.15.5.9.F(2) NMAC provides that the listing of a well on the Oil Conservation Division's (OCD's) inactive well list as a well inactive for more than one year plus 90 days creates a rebuttable presumption that the well is out of compliance with 19.15.25.8 NMAC (the inactive well rule).

An operator may rebut that presumption by providing evidence that the well is in compliance with the inactive well rule.

The well identified above currently appears on the OCD's inactive well list as a well inactive for more than one year plus 90 days. However, Nadel and Gussman Heyco, LLC has provided documentation showing that the well was returned to production in October 2010. The C-115 production report for October production is not due until December 15, 2010. Once the C-115 reporting production for the well is filed, the well should not appear on the inactive well list.

Nadel and Gussman Heyco LLC has rebutted the presumption created by Rule 19.15.5.9.F(2) NMAC as to the well identified above.

Although this well still appears on the inactive well list, until <u>December 16, 2010</u> the OCD should not consider the well as out of compliance with 19.15.25.8 NMAC when determining Nadel and Gussman Heyco LLC's compliance with Rule 19.15.5.9 NMAC.
