Dear John and Kathy Cravey,

The Oil Conservation Division (OCD) has received regulatory filings from John Cravey, dba JRC Petroleum, regarding actions the company intends to take on the Bradley Federal #3 well and the Bradley Federal #7 well.

OCD records do not show John Cravey, dba JRC Petroleum as the operator of record for these wells. I have enclosed a copy of the well list for John Cravey, dba JRC Petroleum, showing the wells for which the company is operator of record according to OCD records.

The Bradley Federal #3 and the Bradley Federal #7 appear in the OCD's records as "pre-ONGARD" wells, with no identified operator. The well files include a copy of an application to transfer the wells from Thornton Hopper to John Cravey with other Bradley Federal wells that John Cravey now operates. However, nothing in the well file shows that Thornton Hopper was the operator of record for the Bradley Federal #3 or the Bradley Federal #7 with authority to transfer the wells. The OCD did not recognize the transfer as to those two wells.

If there is no existing operator of record to approve a transfer, the person seeking to become the operator of record for a well must apply in writing "and provide documentary evidence of the applicant's right to assume operations." 19.15.9.9.B NMAC. Attorney David Brooks reviews such applications. Please submit a written request to Mr. Brooks to become operator of record
