Devon Energy Production Company respectfully requests to drill this well as follows:

The surface casing will be set using an Ashton Oilfield Services rig. The rig plat is attached. This rig will be used only to set the surface casing and will leave the location once the surface casing has been run and cemented. Another rig will drill the remainder of the wellbore. The reasons for using the smaller rig to set surface are: rig availability and economics.

The BLM will be contacted 24 hours prior to commencing drilling operations. The surface casing will be run and cemented back to surface as per the approved APD. The well will be secured with a cap welded onto the surface casing. Another rig will be on location to drill the remainder of the wellbore within 60 days after the Ashton rig has left the location.



Conditions of Approval

1. Notify the BLM when removing the Ashton Oilfield Services Rig.
2. Notify the BLM when moving in the H&P Flex Rig. Rig to be moved in within 60 days of notification that Ashton Oilfield Services Rig has left the location. Failure to notify or have rig on location within 60 days will result in an Incident of Non-Compliance.
3. Once the H&P Flex Rig is on location, it shall not be removed from over the hole without prior approval unless the production casing has been run and cemented or the well has been properly plugged. **If the drilling rig is removed without approval – an Incident of Non-Compliance will be written and will be a “Major” violation.**
4. The CIT for the surface casing shall be performed and results recorded on subsequent sundry – pressure to be 1200 psi.
