1. Remove well head, anchors, flowline, and all other debris from location and install DHM with appropriate information
2. Remove caliche and contaminated soil from location and access roads
3. Put in 2'-3' caliche barrier where needed
4. Put in 1'-2' clean topsoil as needed
5. level and contour to surrounding area
6. Build an earthen berm at access to prevent vehicular traffic.
7. Rip and seed all disturbed areas with BLM #2 Seed mixture using an approved seeder
