Change the intermediate casing string from 8-5/8" 32# J-55 to 9-5/8" 40# J-55.

Cement modification: 965 sx Econcem System with 5% salt, .25 pps Pheno Seal mixed at 12.4 ppg (2.12 cf/sk) followed by 155 sx Halcem System mixed at 14.8 ppg (1.33 cf/sk).

Change the production casing string from 5-1/2" 17# J-55 to 5-1/2" 17# N-80.

Change the 5.5" 17# N-80 production casing string cementing requirements to:

900 sx Expandacem System (foamed cement) with 2% Zonesealant 2000 (foamer) mixed at 15.6 ppg (1.19 cf/sk).
