Devon Energy Production Company L. P. respectfully requests the surface casing to be set using an Ashton Oilfield Services rig. The rig plat is attached.
This rig will be used only to set the surface casing and will leave the location once the surface casing has been run and cemented. Another rig will drill the remainder of the wellbore. The reasons for using the smaller rig to set surface are: rig availability and economics.

The BLM will be contacted prior to commencing drilling operations. The surface casing will be run and cemented back to surface as per the approved APD. The well will be secured with a cap welded onto the surface casing. Another rig will be on location to drill the remainder of the wellbore within 60 days after the Ashton rig has left the location. The BLM will be notified when the Ashton rig moves off location. The surface casing will be tested as per BLM Onshore Orders No.2 when the drilling rig moves on location.

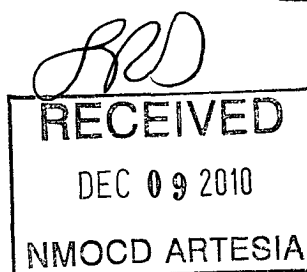
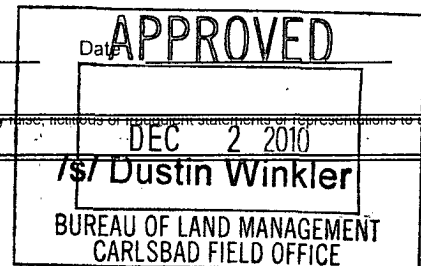
