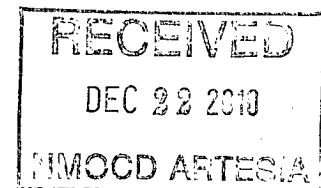

Grader ripped N & W side location. Caliche was used to repair road to Poker Lake Unit Del C Battery and various other roads. After removing caliche grader & loader addressed erosion problem on south side location. Area was ripped, contoured and seeded w/ LPC seed as per BLM.
