11/10/10 – Spotted 35 sx Class "C" Neat cement at 3790'. Calc TOC at 3575'. Spotted 35 sx Class "C" Neat cement at 2345'. Calc TOC at 2129'. Spotted 35 sx Class "C" Neat cement at 1220'. WOC.
