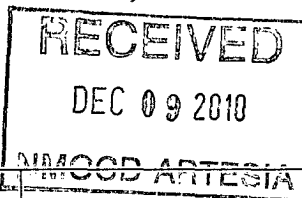

 11/17/10 RIH and tagged plug @ 2046'. Spot 25 sx class C cement. POH. WOC. Tagged plug @ 1936'. Perf'd csg @ 1577'. RIH and set packer @ 1300'. Pressured up to 1300 psi. POH w/ packer. RIH open ended to 1638'. Spot 40 sx class C cement. Pull out of cement WOC overnight.  
 11/18/10 Tagged plug @ 1376'. POH. Perf'd csg. @ 710'. Set packer @ 400'. Sqz'd 80 sx class C cement. WOC.. Tagged plug @ 689'. Perf'd csg @ 684'. Sqz'd 145 sx class C cement. Displaced to 500'. SDFN.  
 11/19/10 Tagged plug @ 440'. POH. ND BOP. Set packer @ 20'. Sqz'd 145 sx class C cement to surface. Pull packer and topped off surface. plug. Cleaned location, rigged down moved off.  
 11/22/10 Moved in backhoe and welder. Dug out cellar. Cut off wellhead. Welded on Dry Hole Marker. Back filled cellar. Cut off dead men. Back drag location. Moved off.
